### 1. Chair's welcome and apologies for absence

### 2. Minutes of Last Meeting and matters arising

It was felt that we have co-opted within our rules. Furthermore WHUST only has one vote on ISA.

#### Actions:

Will continue to work with co-opted members in an advisory capacity. They do not have voting rights and are not bound by any decisions of the board and are expected to vote at ISC as individuals not WHUST board members.
